Sub-Committee Liaison and Member Updates

- Chris Cochran reviewing an internal draft list on land use and development recommendations to share with stakeholders.
- Marian Wolz gave an overview of the Climate Council meeting. Discussion on Just Transitions and
 environmental justice and equity policy. Putting out a RFP to help subcommittees with their
 recommendations and using the guiding principles rubric. Science and Data held a public forum to
 discuss the greenhouse gas inventory and opened to public comment.
- Stephanie Smith explained the BRIC announcement \$600,000 funding, national review done and now to FEMA for approval. Two large dam removal projects were not selected. Direct technical assistance for future mitigation and regional projects approved in Pittsfield (Region 1). Regarding recommendations for program enhancements, small rural states face challenges applying for funds with other large states. Inherent inequities are in the program. 35 of the 200 points awarded, went to states with building codes criterium. The dam removal projects were not ineligible, just not selected.
- Chad Farrell reported on the Cross Sector Mitigation meeting, which had a Just Transitions workshop, and drafted recommendations.
