

# Finalizing Sub-committee membership

## What the Steering Committee heard last week

- The process for finalizing membership feels rushed and missing opportunities to be more inclusive.
- The number of suggestions from the Council was quite large (75!)

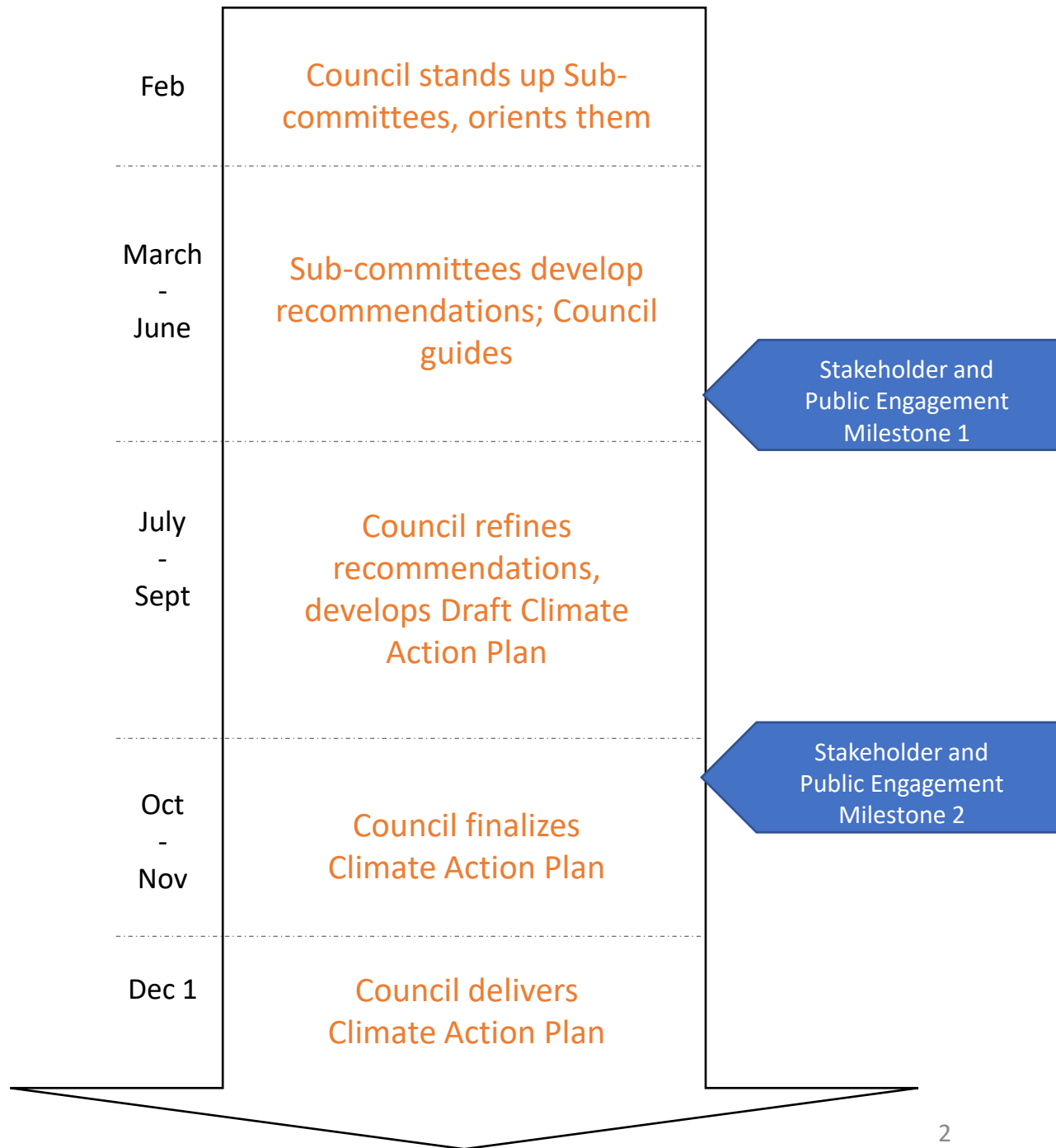
### ***How to adapt the process?***

- **Phased approach** – give sub-committees time to meet and consider their membership options for non-council members
- **Open approach** - Open this up more broadly to the public
- **Multiple paths to engage**: Clarify sub-committee membership vs stakeholder outreach, public outreach and other ways - our “concentric rings”

### ***Concrete next steps***

1. Public survey sent out – responses accepted through Feb 12
2. Sub-committees to meet next week with just council members to review a full list of names
3. Council to sign-off on membership in your Feb 22 meeting

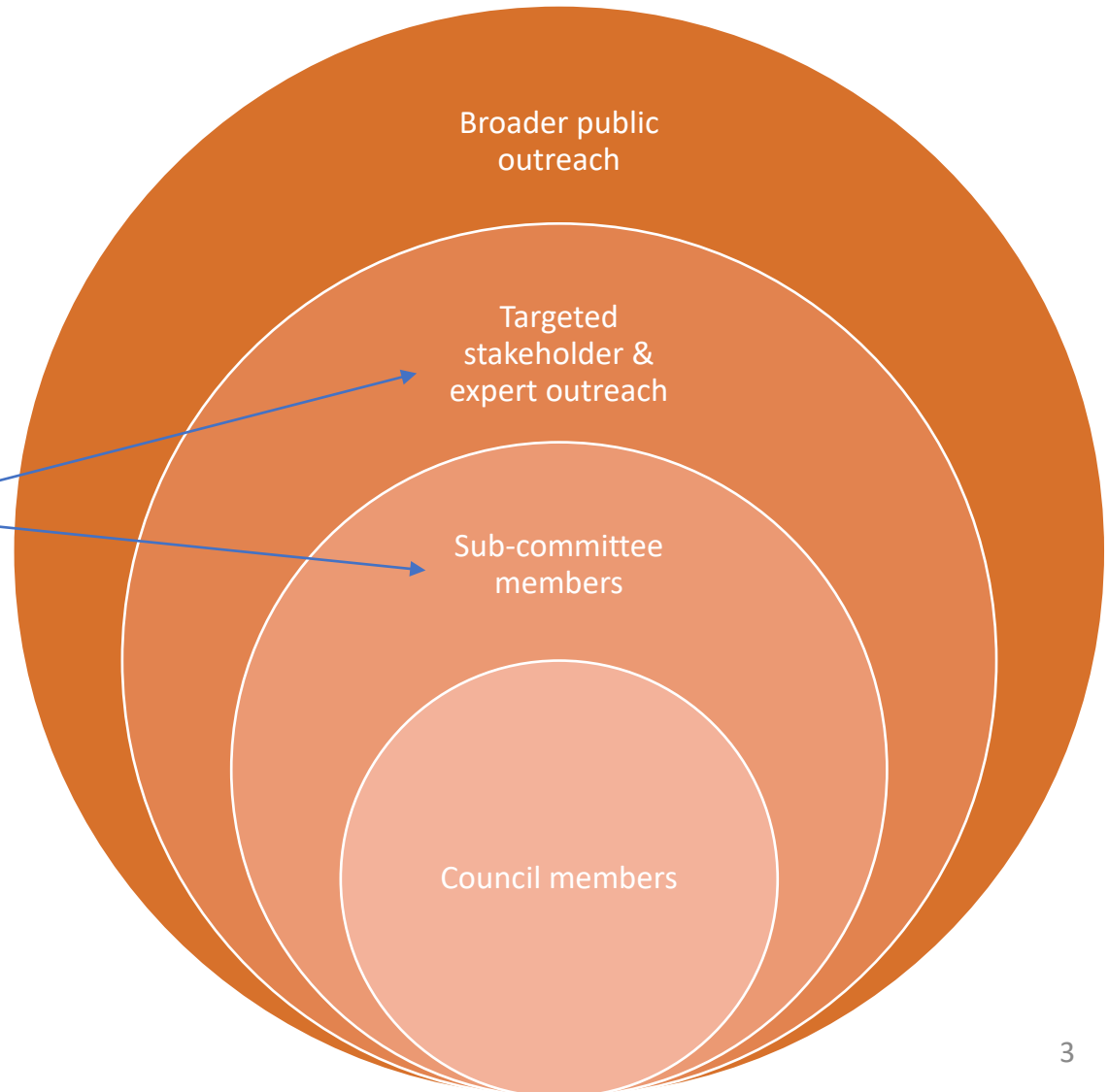
# Vermont Climate Council Process Timeline

## **Criteria for both circles**

- Have a particularly relevant **expertise** for a Sub-committee
- Can share an **important viewpoint** on the issues, bringing demographic, geographic and other balance to the conversation

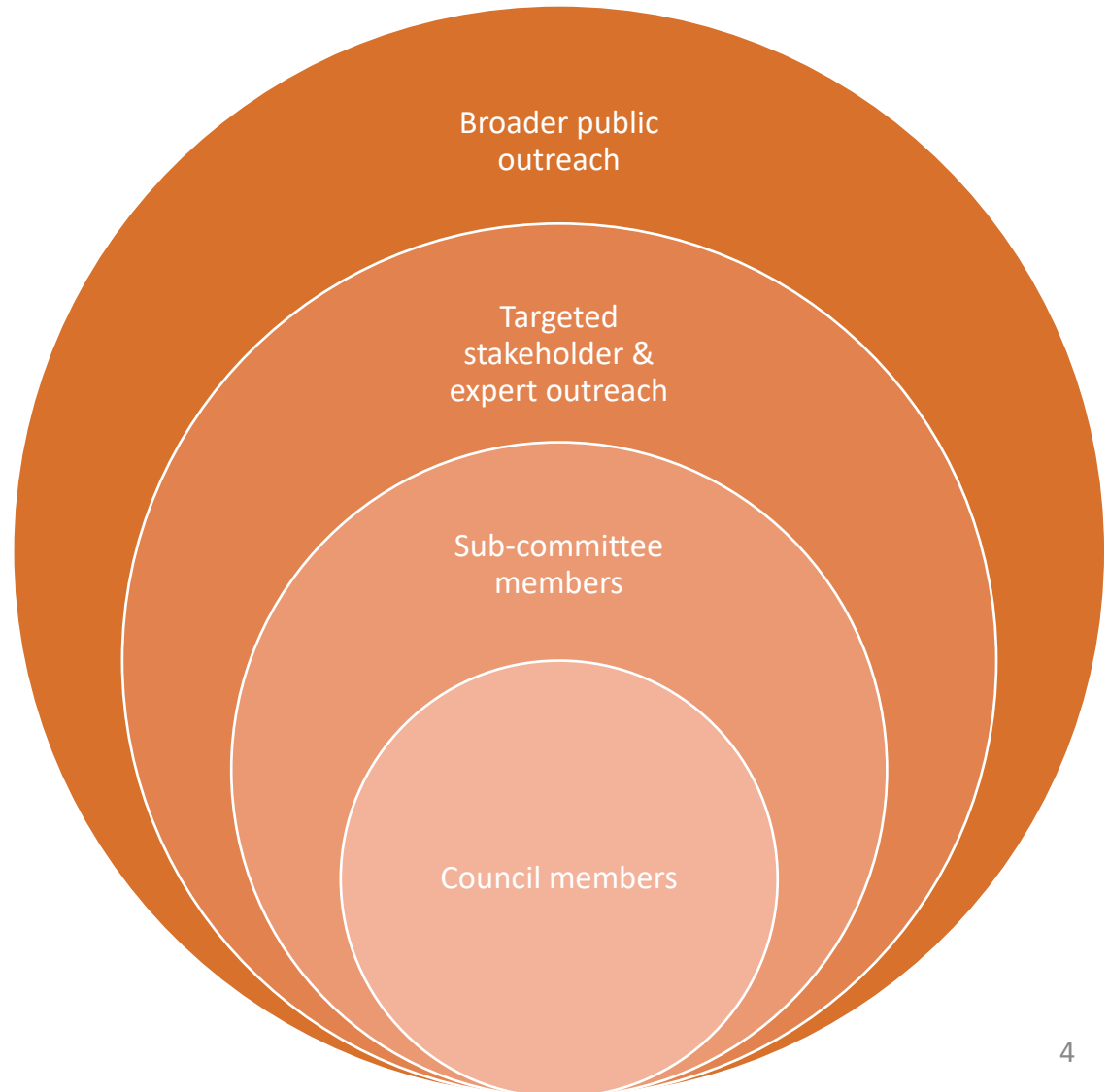


# Circles of engagement

## ***Signaling engagement options in the survey***

What type of engagement would best suit this person?

- Stay apprised of Sub-committee work (ie submit comments, speak to subcommittee members during targeted outreach)
- Attend subcommittee meetings
- Be a subcommittee member (requires an on-going commitment of 4-6 hours a week from March through June)
