Proposed Rule: Aboveground Storage Tank Rules, Agency of Natural Resources, Department of Environmental Conservation

Presented By: Anna Bourakovsky and Andrew Youngs

Motion made to accept the rule by Sean Brown, seconded by Diane Sherman, and passed unanimously except for Jen Mojo who abstained, with the following recommendations:

- 1. Submit an updated rule that highlights changes noted at the beginning of the meeting distinguishing between new and existing installations (received after the ICAR 02/23/24 meeting).
- 2. Proposed Filing Coversheet:
 - a. #8: Reword to include the full scope of changes including the strict requirements, etc.
 - b. #12: Provide an executive summary to align with the Economic Impact Analysis.
- 3. Public Input:
 - a. #3: Provide additional upcoming outreach such as the towns and the newsletter process referenced during the meeting.

Proposed Rule: Unused Drug Repository Rule, Agency of Human Services, Department of Health

Presented By: Brendan Atwood

Motion made to accept the rule by John Kessler, seconded by Nicole Dubuque, and passed unanimously with the following recommendations:

- 1. Proposed Filing Coversheet, #10: Include the "how" as required.
- 2. Economic Impact Analysis:
 - a. Include any relevant data, costs and/or information pertaining to new hires to administer the program.
 - b. #3: Correct spelling "emdicine".
 - c. #9: Describe how the analysis was conducted and identifying the source of information.
- 3. Environmental Impact Analysis, #9: Include more detail.
- 4. Public Input Maximization Plan:
 - a. #3: Include positive impacts, such as those to health, economic and environmental.
 - b. #4: Change "Aide" to "Aid".
 - c. Consider reaching out to others who might be interested in this proposed rule, such as community members and those involved in solid waste.



Proposed Rule: Improved Tracking of Workplace Injuries and Illnesses, Vermont Department of Labor

Presented By: Dan Whipple and Karl Hayden

Motion made to accept the rule by Sean Brown, seconded by John Kessler, and passed unanimously with the following recommendations:

- 1. Proposed Filing Coversheet, #10: Include information pertaining to the loss of jurisdiction to the federal government; or staying in compliance with our state plan.
- 2. Economic Impact Analysis:
 - a. Align with the Proposed Filing Coversheet and include specific economic impacts.
 - b. Clarify numbers are national from the Federal Registry.
 - c. Clarify costs/breakdown.
 - d. #6: Clarify any level of increased reporting requirements.
 - e. #3: Include the estimated costs and benefits anticipated.
- 3. Environmental Impact Analysis, #9: Complete.
- 4. Public Input Maximization Plan:
 - a. #3 and #4: Include who (#4) and how (#3) you are publicizing in Vermont, including outreach to all entities, such as Vermont employers, League of Cities and Towns, etc.
- 5. Incorporation by Reference:
 - a. #5: Include physical office address.
 - b. #6: Note the adoption of OSHA amendments, clarifying reference pertaining to OSHA vs VOSHA.
 - c. FYI: Although it must be as stringent, modifications can be made to what's being incorporated.
